Inhalation Harmful by inhalation. Inhalation of high vapor concentrations may cause symptoms like

4. FIRST AID MEASURES

Fire and Explosion Hazards : Fire may produce irritating or poisonous fumes. Flammable Liquid. Can release vapors

that form explosive mixtures at temperatures at or above the flashpoint. Vapors can travel to a source of ignition and flash back. Empty containers retain product residue (liquid and/or vapor) and can be dangerous. 6. ACCIDENTAL RELEASE MEASURES
